**Child Safe:** Montmorency Secondary College is a child safe environment in accordance with the Victorian Government Guidelines. The College actively promotes the safety and wellbeing of all students, and all school staff are committed to protecting students from abuse or harm in the school environment, in accordance with their legal obligations, including child safe standards. Montmorency Secondary College has a Child Safety Code of Conduct consistent with the Department's exemplar.

Montmorency Secondary College has a smart, distinctive, compulsory College uniform, which forms an important part of the overall Montmorency Secondary College education. Wearing the College uniform correctly reflects the College values, and the pride and respect we have for our College and, more importantly, for ourselves. Students are expected to wear the correct College uniform.

#### **PURPOSE**

The purpose of the Student Dress Code is to outline Montmorency Secondary College's requirements for student dress and appearance and to provide information about uniform purchase and support, dress code implementation and exemption processes.

This dress code has been developed by Montmorency Secondary College's School Council in close consultation with our school community to ensure that it respects the rights of individual students whilst reflecting the values and interests of our community.

The Student Dress Code aims to:

- foster a sense of community and belonging and encourages students to develop pride in their appearance.
- support Montmorency Secondary College's commitment to ensuring that our students feel equal and are dressed safely and appropriately for school activities.
- reduce student competition based on clothing.
- enhance the profile and identity of the College and its students within the wider community.

The School Council has developed a dress code that we believe provides a range of choices for students, is inclusive and is cost effective for families.

The Uniform policy reinforces in students a sense of pride in their appearance and instils recognition of themselves as an integral part of the College community. We believe that a student's individuality at the College will be recognised by such factors as his/her/their personality, scholastic achievement, sporting, leadership, initiative and involvement in college activities.

#### **SCOPE**

Students are expected to comply with this Student Dress Code while traveling to and from school, during school hours and when attending school activities.

#### UNIFORM AND APPEARANCE

The full list of Montmorency Secondary College's compulsory school uniform items is listed in Appendix A to this Dress Code.

Any additional items worn underneath the uniform should be plain white and not visible. All items should be clearly marked with the student's name, so they can be returned to lost property if found.

#### **General appearance**

While at school, travelling to or from school or participating in school activities, Montmorency Secondary College students must comply with the following:

- Uniforms should be clean and in good repair.
- Uniform items should be clean and presentable, appropriately meeting a standard of dress that
  ensures all students are dressed safely and appropriately for school activities and preparing
  students for the expectations of workplaces.
- Uniforms should be clearly marked with the owner's name.
- Additional layers of clothing may be worn underneath the uniform for added warmth, provided these undergarments are completely hidden.

#### Jewellery/Cosmetics/Hair

- Jewellery should be unobtrusive and safe.
- Make-up is not encouraged and, is to be kept to a minimum.
- Only clear nail polish is acceptable. Long nails, especially fake nails, are inappropriate and present a further OH&S risk.
- Hair colour is limited to natural colours. Blue, green, purple or scarlet hair is not acceptable. Long
  hair should be tied back where appropriate for Occupational Health & Safety reasons, especially
  in Physical Education, Science and all Technology classes.

#### Sun safety

As we are a secondary school, we expect students to take responsibility for being sun smart by wearing a school hat during outdoor activities or staying in the shade, if they are not wearing sunscreen. The College encourages students to wear hats from mid-August to the end of April.

In accordance with our Student Dress Code Policy, students are only permitted to wear the MSC beanie, MSC hats and MSC scarf with their College uniform. Students wearing items that are not part of the College uniform will be asked to remove them.

- Students will not be permitted to wear the beanie during class time but are free to wear it on their way to and from school and in the school yard.
- Students are permitted to wear sunglasses during outdoor activities. Sunglasses should be close-fitting, wrap-around that meet the Australian Standards 1067 and cover as much of the eye area as possible.

# **PURCHASE OF UNIFORMS**

#### **Supply of Uniform Items**

#### **Religious and Cultural Considerations**

Montmorency Secondary College is aware that some students may wish to observe religious and cultural requirements while also complying with the school dress code. The College will discuss these requirements with students and parents or carers to ascertain their cultural and religious significance and how they might be accommodated within the College's dress code policy.

#### **IMPLEMENTATION**

Montmorency Secondary College will ensure that this Student Dress Code is communicated to all families and students through our College website, Enrolment Packs and in our College newsletter. We will assist students who may be experiencing difficulties complying with this policy where possible.

If a student is out of school uniform, or otherwise breaches the Student Dress Code on a recurring basis, a note will be provided to the student and parents by the classroom teacher. If non-compliance with the dress code becomes a continued occurrence, the Principal will be informed and a phone call home may be required. In this event, the College will continue to work with the student and family to support compliance.

**Uniform Pass:** Communication from a parent/guardian is required if a student is not able to wear complete uniform for a brief period for a genuine reason. If a student is unable to wear the complete uniform due to medical reasons, then this should be supported by documentation from a relevant medical professional. A uniform pass must be obtained at the start of the day from the Year Level Leader or Year Level Coordinator by any student out of uniform and shown to teachers throughout the day when requested.

Measures taken by Montmorency Secondary College to address concerns about student non-compliance with the Student Dress Code will also be addressed in accordance with our Student Wellbeing and Engagement Policy.

#### Wearing of PE/Sport Uniform

- Students in Years 7-9 may wear their PE Uniform to and from school and all day, on their timetabled core PE sessions.
- Students are required to wear a totally black runner with their PE uniform.
- In Years 8-9, any student undertaking a PE/Sports elective is required to continue to change into/out of their PE uniform for elective classes.
- In Years 10-12, students who have chosen to undertake Senior PE are required to change into/out of their PE uniform for PE classes.

Only the MSC PE polo top and MSC spray jacket/soft shell jacket may be worn over the MSC PE shorts and the MSC track pants when travelling to and from school.

#### **Designated out-of-uniform days:**

Dress for designated 'out-of-uniform' days (including excursions where relevant) should be appropriate to the activity or smart casual, and appropriate to the College context. As they present a real Occupational Health and Safety risk, particularly in Science and Technology classes, **thongs** (or open/ill-fitting footwear) are never to be worn.

If a student has a scheduled PE class on an out-of-uniform day, they must ensure they have PE appropriate clothing. Students wearing items that are deemed inappropriate or offensive will be asked to replace the item.

# **Sports carnivals:**

As our College sports carnivals are House competitions, students are encouraged to dress in their House colours:

Red for Darebin Yellow for Yarra

Blue for Diamond Green for Plenty.

Items worn should be appropriate to the College context and 'SunSmart' guidelines still apply on these days. Students wearing items that are deemed inappropriate or offensive will be excluded until the item is replaced.

#### **EXEMPTIONS TO STUDENT DRESS CODE**

We recognise that there may be situations where the application of this dress code may affect students unequally.

Students and their parents or carers may apply either in writing or in person to the Principal for an exemption to this Student Dress Code if:

- an aspect of this code prevents the student from complying with a requirement of their religious, ethnic, or cultural beliefs or background
- the student has a particular disability or health condition that requires a departure from the dress code
- the student or their parents/carers can demonstrate economic hardship that prevents them from complying with the dress code.

When the Principal receives a request for an exemption, they will:

- consider the grounds for the exemption request.
- explain the process to the student and/or their parents/carers
- encourage the student and/or their parents/carers to support their application with evidence.

The Principal or delegate will then try to negotiate a resolution that is acceptable to all parties. If an exemption is not allowed, then written reasons will be provided to the student and/or their parents or carers.

#### CONCERNS ABOUT THIS STUDENT DRESS CODE

Montmorency Secondary College welcomes feedback from the school community in relation to this Student Dress Code.
